## Whistle Blowing Policy and Procedures

### 1. Policy Statement

- a. Meda Inc Bhd (“Meda Inc”) is committed to achieving and maintaining high standards with regards to behaviour at work as set out in Meda Inc Bhd’s “Principles of Business Conduct”
- b. In order to achieve the standards set out in Meda Inc’s Principles of Business Conduct, all employees and stakeholders (ie shareholders /suppliers /customers) are encouraged to report genuine concerns about unethical behaviour, malpractices, illegal acts or failure to comply with regulatory requirements without fear of reprisal should they act in good faith when reporting such concerns.
- c. Meda Inc views any harassments or retaliations in any form or manner against genuine whistle blower seriously and will treat such action as gross misconduct, which if proven, may lead to dismissal.
- d. The policy and procedures is applicable to all companies with Meda Inc group.

### 2. Whistle Blowing

- a. Whistle Blowing is a specific means by which a staff or stakeholder can report or disclose through established channels, concerns about unethical behaviour, malpractices, illegal acts or failure to comply with regulatory requirements that is taking place / has taken place / may take place in the future.
- b. Only genuine concerns should be reported under Whistle Blowing procedures. This report should be made in good faith with a reasonable belief that the information and any allegation in it are substantially true, and the report is not made for personal gain. Malicious and false allegations will be viewed seriously and treated as a gross misconduct and if proven may lead to dismissal.

### 3. Procedures

- a. Any concern should be raised with immediate superior. If for any reason, it is believed that this is not possible or appropriate, the n the concern should be reported to Group Managing Director. Channel of reporting to Group Managing Director is :

#### 4. Action

- a. All reports will be investigated promptly by the person receiving the report. If required, he can obtain assistance from other resources within the Group (eg Group Internal Audit, Group Human Resource Department, Group Legal Department etc). The progress of the investigation will be reported to the Audit Committee no later than at the next scheduled meeting.
- b. Reports received anonymously will be treated as confidential.
- c. The person making anonymous report will be advised that maintaining anonymity may hinder an investigation. Irrespective of this, anonymity will be maintained as long as it's permitted by law or the person making the report indicates that he no longer wishes to remain anonymous.
- d. Upon completion of investigation, appropriate course of action will be recommended to the Audit Committee for their deliberation. Decision taken by the Audit Committee will be implemented immediately.
- e. Where possible, steps will be implemented to prevent similar situation arising.

#### 5. Further action

- a. If for any reason, the person making the report is not satisfied with the way his report had been dealt with, he can escalate his report to the Chairman of the Audit Committee. Channel of reporting to the Chairman of Audit Committee is as follow:-
